### Banks in the Spotlight: Corporate Responsibility at Work

In observance of Military Appreciation Month, meet the two <u>2023 ABA Foundation Community</u> <u>Commitment award winners</u>, from the Supporting Military Families category.



#### Fulton Bank, Lancaster, PA

Their Fulton Bank Military Internship program is celebrating 10 years. It's a six-month internship that helps veterans transition from military service to the civilian workforce with on-the-job training in the financial services industry. Upon completing the internship, the program provides job search support within Fulton and the banking industry. Since the program's launch in 2019, Fulton Bank has worked with more than 168 veteran interns and hired 42 of them for full-time positions.



## Wells Fargo, San Antonio, TX

In an effort to increase the number of veterans hired at Wells Fargo, they launched the Military Talent Strategic Sourcing program. It consists of military talent liaisons specially trained to recruit, counsel and advocate for them during their application process. These liaisons also help job-seeking

veterans develop transition strategies, build their resume, analyze their skills and practice for interviews.
